## Notice Regarding Partial Amendment to the Articles of Incorporation

Marubun Corporation (the "Company") hereby announces that at the meeting of the Board of Directors held today, it resolved to submit a proposal for a partial amendment to the Articles of Incorporation to the 78th Ordinary General Meeting of Shareholders scheduled to be held on June 26, 2025.

1. Reason for Amendment

The purpose of this amendment is to amend Article 2 (Purpose) of the current Articles of Incorporation in order to reflect the current state of the Company's business, consolidate the description of its business activities, and enable the Company to respond flexibly to future business developments.

2. Details of Amendment

The details of the amendment are as follows. Items not envisioned in current or future business development will be deleted, while items that may arise from current initiatives will be newly established. In addition, the overall description order and wording have been revised.
