Notice of a Change to an Audit & Supervisory Committee at the Company and Transfer of Executive Personnel

Marubun Corporation (the Company) hereby announces that a meeting of its Board of Directors held on May 18, 2015 resolved to change to a company with an Audit & Supervisory Committee, which has been newly introduced by the Act for Partial Revision of the Companies Act (Act No. 90, 2014) that came into force on May 1, 2015 and accordingly transfer the executive personnel as follows.

The change is subject to the approval of the necessary amendment of the Articles of Incorporation at the 68th Annual General Shareholders' Meeting scheduled on June 26, 2015.

1. Purpose of the change

We have resolved to become a company with an Audit & Supervisory Committee. In the Audit & Supervisory Committee, Outside Director occupy the majority in order to further enforce the supervisory function of the Board of Directors and to implement prompt decision-making by separating the supervision and the execution of operations. By delegating a substantial part of the Board of Directors' authority to execute operations to the vice presidents under the new system, we are aiming to improve the efficiency and mobility, as well as to improve the soundness and transparency of the management through the strengthening of the corporate governance system.

2. Time of the change

Changing the Company to one with an Audit & Supervisory Committee has been planned to be made after the approval of the necessary amendment of the Articles of Incorporation at the 68th Annual General Shareholders' Meeting scheduled on June 26, 2015.
